Official Rules:

Your LiveF5 Is Showing Official Rules

No purchase necessary. Void where prohibited. Some restrictions apply.

The contest: From 09/01/10 through 09/30/10, comF5TM will promote, by means of our community and on our official Facebook Fan Page, the opportunity to submit entries to win a grand prize as detailed below. Social Media Outlets may also be used to promote the contest beginning 09/01/10 through 09/30/10.

Eligibility: In order to submit entries, you must be a ComF5 customer or Reseller. Any individuals (including but not limited to employees, consultants, independent contractors, and interns) who have, within the past six months, performed services for ComF5 or any organizations responsible for sponsoring, fulfilling, administering, advertising or promoting the contest or supplying the prize, and/or their respective parent, subsidiary, affiliated and successor companies, and immediate family and household members of such individuals, are not eligible to enter. "Immediate family members" shall mean parents, stepparents, children, stepchildren, siblings, stepsiblings, or spouses. "Household members" shall mean people who share the same residence at least three months in one calendar year.

How to enter: (1) Record your show using LiveF5 broadcast tools. (2) Post a link to this show on the Official ComF5 Facebook fan page. (3) Promote this link everywhere.

How to win: The winner will be selected from the top 10 finalists and chosen by a panel of judges, consisting of ComF5 leadership and management. Judging will be based on who best achieves the goals of this promotion, which are creativity in using LiveF5 for promotion, creating brand awareness, having fun and inspiring others to do the same. The top 10 finalists will be determined by who gets the most likes and comments associated with posting their show's link on



ComF5's Official Facebook fan page. In the event that the original Grand Prize winner does not meet Official Rules or eligibility requirements, or he/she or parent or legal guardian forfeits the Grand Prize, ComF5 will award prize to first alternate. Process will continue until Grand Prize is awarded.

The selection will be held the week of 10/04/10 thru 10/08/10. Decision of the judges and ComF5 is final. The Grand Prize winner will be notified by email and/or phone and must meet all eligibility requirements.

By entering, each contestant agrees to be bound by the rules. ComF5, its promotional agents and contest co-sponsors are not responsible for content, broken links or malfunctions of Facebook commenting and Like system.
